Treasurer's Report – update on FY18 audit and related matters:

Ian Rhames said the FY18 financial audit is in progress. Mr. Rhames said he received a legal notice stating that Lynch Marini Associates should be the auditor for fiscal year 2018. He said they were basing that on a letter signed by Tony Logalbo regarding a three-year price proposal. Mr. Rhames said a price proposal is not a letter to perform the audit. He said the MNHG legal team has provided a rebuttal to Mr. Marini's lawyer.

Mr. Rhames said he will report on the financial statements at the Board meeting.

Other Business:

Carol Cormier asked if any of the employers heard from their employees following the MyTelemedicine mailing.

A few employers said they received a phone call from Jeff Beane, MyTelemedicine Account Manager.

Carol Cormier said Mr. Beane will be reaching out to each unit and is willing to speak to the employees on site. She said behavioral health visits are included in the benefit.

Erin Hayes said dermatology has been added to their telemedicine program. She noted that if a telemedicine PCP prescribes a medication and is not on the Tufts formulary, the medication may not be covered.

Carol Cormier said she would contact Jeff Beane to ask about that.

Kerry Lafleur asked for a report on the employer contributions to the health plans. She said she had a request to provide it to their Insurance Advisory Committee.
